Sponsor may disqualify previously published essays or those that have won previous awards or competitions. Limit one (1) entry per person.

Sponsor will not be responsible for incomplete, lost, late, postage-due, misdirected, or illegible entries, Entries that do not fall within the 500 - 1,000 words limit or that do not comply with the provisions of these Official Rules will be disqualified. All entries become property of Sponsor and none will be returned. Contestants acknowledge and agree that Sponsor and Promotional Sponsor shall have the right to edit, adapt, modify, reproduce, publish, promote, create a sound recording of, broadcast, or otherwise display or use entries in any way it sees fit without limitation or compensation to entrants. Sponsor further reserves the right to disqualify any entry that is alleged to infringe on any third-party's intellectual property rights, or that Sponsor, in its sole discretion, deems obscene, offensive or otherwise inappropriate for viewing by a general audience. <u>Winner Selection</u>. A panel of qualified judges selected by Promotional Sponsor will judge all eligible entries according to the following criteria: 50% content of essay/appropriateness for theme, and 50% clarity of writing. The ratings scale for each criterion will range from one (1) to ten (10), with ten (10) being the best score. Judging will conclude no later than May 1, 2018. The one (1) contestant with the highest cumulative score will be designated the Winner. In the event of a tie, tied entries will be re-judged on the same criteria listed above. Decisions of judges and Sponsor shall be final and binding in all respects.

Prizes and Odds. Winner will receive a \$1,000 scholarship, provided by the Cincinnati Enquirer. The scholarship shall be applied to the winner's first year's college tuition (\$1,000). Winner must enroll as a full-time student in a degree program at a college, university or community college/regional campus to be eligible to receive the prize (65-mile radius of downtown Cincinnati). Winner must present an enrollment verification or other proof of full-time, degree-seeking enrollment to receive the scholarship award. If Winner does not enroll full-time in a degree program in a university, college, or community college/regional campus *located in Greater Cincinnati*, he/she will forfeit his/her right to receive the scholarship.
