

Stephen Kenny

Jon McKamey

Dr. Jon P. McKamey is an instructional designer and professor at Cincinnati State Technical and Community College. He arrived at the former Cincinnati Technical College in July 1987 as the Coordinator of Media Services, working with classroom technology until 2003 when he joined the faculty as the college's instructional designer. He was awarded tenure in 2008. In the Office of Online Learning, he is chiefly responsible for the design and development of remote learning opportunities and assisting his colleagues to integrate technology into all course modalities. Dr. McKamey has developed and taught Educational Technology for the Early Childhood program and an online College Survival Skills course for the First Year Experience department. He is a past recipient of the House Bruckmann Faculty Excellence Award and the college's Loyal Service Award. Dr. McKamey holds a PhD in Computing Technology and Education from Nova Southeastern University and bachelors (Radio-TV-Film) and master's (Educational Media) degrees from Indiana State University.

Julianna Johns

Julianna Johns is the Director of Cincinnati State's Center for Teaching and Learning (CTL) and is a tenured professor of Biology, entering her 30th year teaching natural science courses and skills for science courses in secondary and higher education settings. As the Director of the CTL, Julee has presented and facilitated a variety of professional development opportunities for faculty. The CTL serves the entire College, with a focus on teaching and learning activities. Since March 2020 the CTL, in collaboration with Cincinnati State's Office of Online Learning, has helped over 600 faculty members transition to fully remote instruction. Julee is an author of the Cincinnati State course "Integrated General Biology and Skills for Success in Science" that prepares students in Health and Allied Health programs for challenging gateway courses, like Anatomy and Physiology. As a research scientist Julee is examining conflicts that exist between males and females with respect to reproduction, referred to as Sexually Antagonistic Co-Evolution (SAC).

With this company, he developed a plan for companies to transition from old OSHA regulations to the new Global Harmonization System. During his career, he has also worked in partnership with 3 software companies overseas o process information on chemicals. Dr. Singh was also a consultant with the Fernald nuclear facility on environmental regulations. Notably, he wrote one of the first books on Bioterrorism. While at Good Samaritan College of Nursing and Health Science, he has received the Outstanding Professor award 3 times.

Jeffrey Kuznekoff

Jeffrey H. Kuznekoff is an Associate Professor in the Department of Interdisciplinary and Communication Studies in the College of Liberal Arts and Applied Science (CLAAS) at Miami University Middletown. He started at Miami in 2013 and earned his BA from Marist College (2003), his MS from Illinois State University (2005), and Ph.D. from Ohio University (2012). He has taught 13 different courses at Miami and serves as the primary advisor for students majoring in Communication Studies and Health Communication. His research interests focus on how people use new communication technologies to interact with others and the ways that communication is altered by these new technologies. His most recent work examines student viewing behaviors in online classes (AURCO Journal), the influence of student texting messaging, during classroom lecture, on student learning (Communication Education 2013; Communication Education 2015) and investigating issues of gender voice in multiplayer video gaming (New Media & Society). In 2019, he co-authored a book examining technology in higher education. He has received several teaching awards, including the 2012 Pamela J. Cooper Award for Teaching by the Central States Communication Association, the 2019 Faculty Achievement in Advising Award (CLAAS), the 2020 Faculty Achievement in Teaching Award (CLAAS), and was recognized by Cincy Magazine as an Outstanding Educator in 2019.

Andrea Hulshult

Andrea Hulshult is an Assistant Professor of Computer and Information Technology at Miami University. She holds a Doctorate of Education in Career and Technical Education from the University of Wisconsin-Stout. Dr. Hulshult's award-winning research focuses on using Agile in higher education to enhance teaching and learning and to improve group work among students. She is passionate about providing students and local non-profit organizations industry knowledge and experience of Agile and works to combine these efforts in her classes. In addition, Dr. Hulshult also teaches classes that help students to think about how technology affects themselves and our society so that students can find ethical ways of using technology. Dr. Hulshult and a colleague developed an ICAgile-accredited Agile concentration at Miami University, which is the first of its kind at any higher education institution.

Brad Egelston

Brad Egelston is the Math Specialist at the Middletown campus. He graduated from Miami University in 2000 with a BS in Education and a Mathematics concentration. In 2005, he earned his M.A.T. from Marygrove College. Brad has been teaching since 1996. He spent his undergrad years getting classroom experience teaching for Middletown City Schools' summer enrichment program. He taught math (and a tiny bit of history) in the Middletown and Northridge school districts for almost 15 years. In 2013, he transitioned to teaching and tutoring in higher education. Brad helped to build and shape Cincinnati State Middletown's peer tutoring program and taught developmental math there and at Sinclair. Among his proudest accomplishments, he has supervised the research of over 80 students during his time at NKU. Dr. David Askew received his Bachelor of Science and Ph.D. degrees at the University of British Columbia, Canada. After completing postdoctoral fellowships at the National Cancer Institute-Frederick National Laboratory for Cancer Research in Maryland and St Jude Children's Research Hospital in Tennessee, he joined the faculty at the University of Cincinnati College of Medicine where he is currently Professor in the Department of Pathology and Laboratory Medicine. Dr. Askew is a Fellow of the American Academy of Microbiology and he directs an NIH-funded research program that studies mechanisms of virulence in the human fungal pathogen *Aspergillus fumigatus*. Dolly Cohen Award for Excellence in Teaching (the University's highest level and honor that recognizes achievements and contributions to teaching -- and a student nominated award) that recognizes individuals committed to excellence in teaching, demonstrating creativity, respect for diverse opinions and experiences, and provides an atmosphere that fosters self-confidence, positive self-concept, and mutual respect.

Colin Bischoff

Colin Bischoff is an observational cosmologist who studies the polarization of the Cosmic Microwave Background using telescopes at the South Pole as a member of the BICEP and CMB-S4 Collaborations. The Cosmic Microwave Background is the oldest light in the universe and statistical properties of its polarization pattern hold the key to understanding the initial conditions of our universe. Colin earned his PhD from the University of Chicago in 2010 and spent six years at the Harvard-Smithsonian Center for Astrophysics as a postdoctoral fellow and research associate before moving to the University of Cincinnati as an assistant professor in 2016. Astronomy is a data-driven field that relies on cutting-edge computational and statistical techniques. As an instructor, Colin introduces his students to this side of the discipline through hands-on computing assignments that combine data inspection, visualization, and analysis. These assignments develop transferrable skills in data science and provide insight into the actual day-to-day work of a modern astrophysicist.

UC BLUE ASH COLLEGE

J.A. Carter

Since joining UC Blue Ash in 2018, J.A. Carter has quickly become an invaluable campus leader. Dr. Carter is a champion of equity and inclusion, hosting LGBTQ Safe Zone workshops and serving as co-leader of a learning community, which addresses LGBTQ students' needs. As the Canvas Leader, Dr. Carter led a successful college transition from Blackboard to Canvas before helping nearly 300 professors move to the remote learning environment as the Covid-19 pandemic hit. Her work in these areas was acknowledged when she was awarded the 2020 Provost's Award for Faculty Excellence. In her role as an Assistant Professor, Dr. Carter teaches sociology courses, including Intro, Social Inequality, Gender, and a Global Community course that she also taught at the Xi'an International Studies University Summer Institute in Xi'an, China in 2019. At the core of her teaching philosophy is a love for challenging students to directly engage course concepts in examining current events and their own lives. As one student recently remarked, Dr. Carter's course was "truly inspiring, and I'm still finding ways to apply what we learned on a daily basis." Dr. Carter also attempts to inspire through research and community involvement that advocates for institutional change. This has included leading two recent studies that address the lack of LGBTQ curriculum in family medicine residency programs and serving on the Local School Decision Making Committee of a CPS elementary school.

Michael Goldcamp

Michael Goldcamp is a Professor of Chemistry at Wilmington College, who arrived at WC as a full-time faculty member in the fall of 2003. He earned a Doctorate degree in inorganic chemistry from the University of Cincinnati in 2002 and spent a year as a National Research Council Postdoctoral Fellow at the National Institute for Occupational Safety and Health (NIOSH/CDC), working with Dr. Kevin Ashley in the field of developing methods for monitoring workplace environments for exposures to hazardous metals. At Wilmington College, Michael teaches the first-year chemistry courses, the organic chemistry sequence, and the general education physical science course. In his time at Wilmington College, his research publications include sixteen student co-authors, working on projects such as the synthesis of transition metal complexes, the development of

He also was a recipient of teaching excellence awards from the Southwest Ohio Council for Higher Education (SOCHE) in 2008 and the GC3 in 2018.

Edmond Hooker

Dr. Hooker was born and raised in Richmond, Virginia. He received his B.S. degree from Hampden-Sydney College in Virginia. In 1985, he earned his M.D. degree from Eastern Virginia Medical School. He then completed his residency training in Emergency Medicine at the University of Louisville. In the spring of 2007, Dr. Hooker earned his Doctorate in Public Health from the University of Kentucky. Since 2003, Dr. Hooker has been teaching in the Department of Health Services Administration at Xavier University. He teaches medical terminology to the undergraduate students. In the graduate program for Health Services Administration, he teaches clinical medicine and population health. In 2015, he was promoted to Professor at Xavier University.
